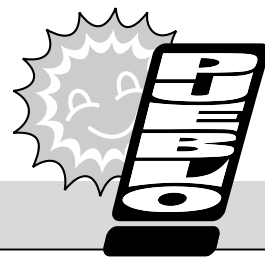

## Radical snow meltdown

USDA 6/5—Colorado experienced a continuation of warm and dry weather during May. According to the latest snow surveys conducted by USDA-Natural Resources Conservation Service, the state's snowpack had decreased to only 26 percent of average on June 1.

For the second consecutive month, Colorado's statewide snowpack percentages dropped sharply. Back on April 1, snowpack had reached 94 percent of average. But by May 1, that same statistic had decreased to 65 percent of average, according to Allen Green, State Conservationist with the NRCS. Rapid snowpack meltdown has occurred in all the state's drainage basins.

Precipitation measured at higher elevation SNOTEL sites across Colorado confirms the dryness

for the month of May. Statewide, precipitation totals for April were only 46 percent of average, with well below average monthly totals measured in all basins.

Across the southern mountains, there has been little change from the below average streamflow volumes anticipated in those river basins. Most of the streams and rivers throughout the Rio Grande basin and southwestern Colorado can expect runoff volumes of only 50 to 70 percent of average this summer, with peak flow volume earlier than normal.

Reservoir storage across most of the state is in good condition right now and is significantly higher than last year at this time in many basins. At many reservoirs the early snowmelt has been captured in storage which is reflected in the recent statistics. (See table on page 3.)

**PERSPECTIVE** by Jon Heaton, Tribune editor

“...look forward to your attention to this matter.”

Those were the final words of a message put on my answering machine Tuesday afternoon about 4 o'clock. Unfortunately, I have no idea who left the message or what it was. Apparently, the machine goofed. Please get in touch if you are the gentleman who called.

**When fantasies fail, some readers say, “Get a calculator.”**

Some of our readers took issue with my estimate of \$2 trillion to care for our wounded military from the occupation of Iraq and Afghanistan, presently totaling about 60,000. I quote from last week's column:

“• Plus the \$2 trillion (and counting) estimated cost of taking care of our wounded, many for the rest of their lives. That's \$667 billion for each of the three years we've been in Iraq.”

Honestly, I can't give you my source for that figure, although I'm thinking it was the Congressional Budget Office.

What makes the care of wounded personnel more expensive is the wonder of body armor, which protects the trunk of the body. It has kept wounded personnel alive in spite of horrendous damage to their extremities. In other words, in previous wars many of these wounded would have been fatalities.

But tragically serious wounds mean a tremendous effort must be made to help these people build a decent life in spite of their war-inflicted handicaps and to support their efforts throughout their lives. So, the pricetag is going to be higher for the “average” wounded veteran than it has been after previous conflicts.

Next, we must consider inflation over the next 50 to 60 years of these veterans' lives. It will surely average no less than 3 percent annually.

Another factor is interest on all this expense. It will be borrowed money because we Americans and our leaders like to spend but refuse to pay our debts. Long-term debt will run at least 3 percent, also.

Put inflation and interest together, and you get 6 percent. Now, let's do some more math:

Compounding \$100 at 6 percent annually for 30 years, you come up with \$574.40!

If half of our wounded require assistance for the rest of their young lives, our VA will probably be helping them for about 60 years. That \$100 compounded for 60 years totals \$3,112.00! The average would climb to about \$889 for every \$100 in current dollars.

If a seriously wounded vet requires support of \$30,000 annually for 60 years (including a sizeable amount up front for surgical/medical, therapy, training, and prosthetics), the average payment in adjusted dollars could be about \$266,700 a year. In 60 years, that's about \$16 million for each vet.



The total for 30,000 vets is \$480 billion, which isn't quite half of \$1 trillion, let alone \$2 trillion.

So, add just a third of \$480 billion (\$160 billion) to the other \$835 billion and you get \$995 billion. Divide that by \$122 billion gallons of vehicle fuel and we are paying a hair more than \$8.16 a gallon. Even with these more conservative estimates, we're still paying three times the pump price of \$2.60 (plus fuel tax) to drive our vehicles.

And, if we shirk our future duty to our disabled veterans altogether, our outlay of \$835 billion annually amounts to \$6.84 (plus fuel tax) for every gallon of gas we put in our vehicles. On the other hand, if annual combined inflation and interest turns out to be as much as 4 percent higher, vet care costs would eclipse our \$2 trillion estimate.

These scenarios suggest that alternative fuels which cost us double might well be a bargain. *jfh*
