Rithmetic and Pueblo...

Math is the last of the "Three R's" and it was discussed this past week by a large group of educators, business people, and citizens. For my regular readers, you know I've wrote about D60's math programs several times over the past few years. Math has become the Achilles' tendon of our education system; reflected by poor CSAP scores and poor outcomes of many students moving on after high school.

It was no surprise that business and higher Ed leaders presented a gloomy picture of math abilities coming out of our schools. Everyone knows that already. A few weeks ago, I was in a local store and purchase something that came to six dollars and change. I gave the clerk a ten, which he entered as twenty. He had to call the manager to find out what to do!

One of the comments was that it was a problem we're still teaching math the way it was taught fifty years ago. That's not entirely true, we're teaching math as it was 25 years ago. Fifty years ago, kids coming out of high school knew how to do math! In the 1970's, educators came up with lots of new ideas to make math more meaningful. Using fancy concepts, graphics, and words to explain the ideas of math.

Well, pooky on that. When you hear middle and high school teach-

ers complain that kids don't know their multiplication tables, we know why. We're making math more warm and fuzzy; rather than accepting that $6 \times 7 = 42$, we're working concepts of theoretical math into third grade. Since junior high, I've known that $Pi \ D = \text{Circumference}$. And in the almost forty years since, including time in engineering and computer related fields, I've never, ever had to know why. It just is! And I'd mention that I'm a tactile learner, but it has never bothered me nor probably 95% of the millions that went to school when I did. Except perhaps those that went on to post-graduate math degrees.

The place for discussing theorems and constructs is in advanced algebra, trig, and calculus, not in third grade math or basic geometry. We need to understand that virtually all kids CAN memorize basic math concepts and formulas. It doesn't hurt them and the more advanced learners will have plenty of opportunity in the future to apply higher level concepts.

Not only has math not changed much in the past 50 years, it hasn't changed in the past 500 years. Just grin and learn it, kids.

Pueblo v. Vegas

In the past month I had the opportunity to see "Phantom of the Opera" at the Venetian in Las Vegas. Without a doubt, this was an excel-

lent production, rivaling and perhaps surpassing the Broadway show. I'd highly recommend it.

I also had the opportunity to see the D60 production of "Cats" here in Pueblo. I have to preface this by saying that when my wife told me she got tickets, I was like "um, yeah, that's nice". "Cats" wouldn't make my top ten list of things to see and a school production of it yet?

Well, I was 100% wrong. It was one of the best things I've done for ten bucks in a long time. The kids were fantastic. The acting and intensity of every cast member was phenomenal. The choreography and singing was top-notch, as was the orchestra. It was a professional level performance and kudos to the kids and staff that had to work incredibly hard to put this together.

There were some empty seats and we, as a community, need to get out, pack that theatre, and support truly wonderful efforts like this. I can't wait to catch the next show they put on!

Statewide testing of geese for avian flu reveals no presence of H5N1 virus

Colorado Wildlife 7/14 - Colorado Division of Wildlife (DOW) officials collected over 3,000 samples from Canada geese around the state as part of their effort to monitor for the presence of the highly pathogenic H5N1 avian influenza virus. Preliminary results from testing at the Colorado State University Diagnostic Laboratory in Fort Collins revealed no detection of the H5N1 strain, further supporting the findings elsewhere that H5N1 has not yet spread to North America.

"These results should help to assure Coloradans that our resident geese presently do not harbor the H5N1 strain and only a small percentage carry the low pathogenic avian influenza viruses that occur naturally," said Laurie Baeten, wildlife veterinarian for the DOW. "Our pilot goose testing program shows that we also should be able to detect the H5N1 strain in Colorado through similar survey efforts if

that strain ever makes its way to North America and becomes prevalent."

There are over 100 strains of avian influenza, called low pathogenic avian influenza, that occur naturally and do not cause serious illness in birds. These low pathogenic strains are known to be present in wild birds worldwide and do not pose a health risk to humans or poultry. The goose testing did detect evidence of a low pathogenic strain of avian influenza in a few of the geese sampled. Three birds tested positive for a low pathogenic strain, none of which showed evidence of illness when samples were collected. All three positive birds were from Walden Pond, located in Boulder.

The goose testing project is part of the State of Colorado's more comprehensive program, being conducted in cooperation with other state and federal agencies, to es-

establish an early detection program for the H5N1 strain in case infected wild birds reach the United States or Colorado through migratory paths.

"Our primary focus is on monitoring the potential interaction of local flocks that may co-mingle with migratory birds coming out of Alaska," said Baeten.

In April of 2006, the state established a dead bird reporting system for avian influenza in conjunction with the existing system for West Nile virus. Persons who find dead wild birds or would like to report sick or dead domestic birds in their area should call the Colorado Health Emergency Line for the Public (CO HELP) at 1-877-462-2911.

The emergency line staff is available to work with the public to receive and appropriately relay and coordinate any information they have about dead birds and to an-

swer their human health questions.

The protocols for handling a dead bird include:

- If the bird is a waterfowl, shorebird, wild raptor or game bird, the hotline staff will collect location information on the number of dead or affected birds. If more than two birds are reported the staff will direct callers to the Division of Wildlife for follow-up.
- If the bird is a songbird, hotline staff will collect location information on the number and the type of birds affected. If there are less than 4 dead songbirds, callers will be advised of proper disposal procedures. If there are 5 or more dead songbirds, callers will be directed to the Division of Wildlife.

The CO HELP hotline is operated by the Rocky Mountain Poison and Drug Control Center under contract to the Colo. Dept. of Public Health and Environment's Emergency Preparedness and Response Program.
