Frank's retirement is a tremendous loss to PCS and the community and he will be missed.

Of course, this leaves an opportunity for Dr. Covington to do the right thing and put another visionary in the position of technology director. And that he must do, for if we want to create "World-Class Schools," we need to give our students the ability to use world-class technology. I can think of one or two people right here in Pueblo that can fit that bill and move the district forward.
