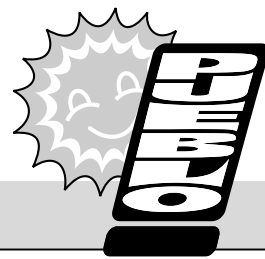

State apartment market tightens

CoDivHousing 9/15—Apartment vacancy rates in Colorado continued to decline during the second quarter of 2007, with Grand Junction, Metro Denver, and Colorado Springs experiencing some of the tightest markets seen in several years, according to a new statewide vacancy report. The only increases in vacancy rates were reported in Fort Collins and Greeley where large student populations vacated apartments for the summer break.

The second quarter's *Vacancy and Rent Survey*, released by the Colorado Division of Housing, also reported that changes in average rents were small with only Fort Collins reporting a significant shift toward higher rents.

Grand Junction by far has the fewest vacancies among the areas surveyed, reporting a vacancy rate of 2.1 percent. Grand Junction continues to be tight as a result of recent economic growth fueled by the oil and gas industry. Vacancies have not risen above 3 percent in Grand Junction since late 2005.

"Grand Junction has long been notable for its affordable rentals," said Kathi Williams, Director of the Colorado Division of Housing, "but finding housing of any kind, affordable or otherwise, has now become quite a challenge there."

In the Denver Metro area, vacancy rates reported earlier this year show the area at a 6-year low of 6.2 percent, but throughout the rest of the Front Range, vacancy rates have still not returned to the low levels seen before 2002.

In Colorado Springs, where vacancies declined from 11.7 percent to 9.6 percent during the second quarter, vacancies are at a five-year low, and vacancies dropped in Loveland from 12.8 percent to 10.4 percent. Vacancies declined in Pueblo from 9.2 to 8.4 percent, but in general, areas with vacancy rates above 5 percent would not be described by experts as tight markets.

In college towns Fort Collins and

Greeley, graduation and summer break likely drove the increase in vacancy rates. During the second quarter, Fort Collins reported an increase in vacancies from 7.0 to 8.5 percent and Greeley reported an increase from 7.2 to 8.3 percent. Vacancies in both areas have generally declined since the 1st quarter of 2003 when vacancies in Fort Collins and Greeley peaked at 13.9 and 14.5 percent respectively.

This is the first time the vacancy survey has been conducted during the second quarter, so comparisons to previous second quarter numbers are not possible.

Average rents in Fort Collins are at an all-time high, increasing to \$800.88 from \$758.27 during the second quarter. Average rents declined in Colorado Springs from \$700.66 to \$683.06 and in Greeley from \$623.99 to \$596.19 during the second quarter. Changes in average rents were minimal in other survey areas.

"What I'm hearing in northern Colorado is that the rental market is mostly healthy," said Terrance Hunt, a broker for Apartment Realty Advisors. "We're figuring that the increase in vacancies up there is due largely to the student factor."

There is optimism in Pueblo as well. "Movement in vacancies often proceeds very slowly in Pueblo," said Ken Greene, a broker who specializes in southern Colorado for Apartment Realty Advisors. "Pueblo doesn't often boom, but they don't have big busts either, so this slow movement downward in vacancies speaks well of Pueblo's market. Pueblo's economy also continues to diversify which should also help the multifamily market."

In Northern Colorado and Pueblo county, high foreclosure rates have become common, and in recent years, it looked like foreclosures might accelerate a decline in rental vacancies. But it is still not clear how recent foreclosures in the state will affect the rental market. "For people with a down payment ready,

there's never been a better time to buy a house," said Kathi Williams, Director of the Colorado Division of Housing which monitors statewide foreclosure rates. "Foreclosures are surely driving former owners back into rentals, but renters who have been saving instead of spending in recent years may start to leave rental housing behind. There appears to be movement in both directions."

Terrance Hunt also noted that in the Denver Metro area and in northern Colorado, a "shadow market" made up of foreclosed homes and condos now being rented out is also affecting the multi-family industry.

According to Gordon Von Stroh, the report's author, and a professor of business at the University of Denver, there is no one trend in rental housing in Colorado. "One thing that might strike you about the rental markets in this survey is how each market is so different. In Colorado Springs, there is the instability of the troop situation and the war. There are the students in Northern Colorado, and there is the oil and gas economy in Grand Junction. It's still clear, though, that we're still not back where we were with the very tight markets of the late nineties."

"The fact that every region is different makes this survey all the more important to us," said Susan Kirkpatrick, Executive Director of the Colorado Department of Local Affairs. "In Colorado, there is no one-size-fits-all when it comes to rental markets."

The Vacancy and Rent Surveys are a service provided by the Colorado Division of Housing to renters and the multi-family housing industry on a quarterly basis. The Survey reports averages and, as a result, there are often differences in rental and vacancy rates by size, location, age of building, and apartment type. Health Dept. phone fraud

PbloHealth 9/21 – Earlier this week the Pueblo City-County Health Department (PCCH) received complaints about a person representing themselves as a Health Department employee making phone calls to people in the community asking for donations and personal information.

“The Health Department does not call households and ask for money,” stated Dr. Christine Nevin-Woods, executive director of PCCH. She explained that when making an official phone call, a PCCH staff member will always introduce themselves giving their name, and title, stating they work for at the Health Department.

She said, “Employees will already know certain facts that relate to the reason for the phone call. A person can also call the main Health Dept. number: 583-4300 during...business hours (8 a.m.-5 p.m.) and ask to speak with a particular staff member to verify if the phone call is legitimate.”

Nevin-Woods added, “If you receive a phone call from someone at an odd hour of the night, identifying themselves as working for the Health Department and/or asking for personal information, question the validity of the phone call by asking for their name, title, work number, and division they work for at the Health Department.”

PCCH emphasized that these impersonation phone calls should be reported to local law enforcement. Provide any leading information, such as a phone number that appears on caller I.D.
