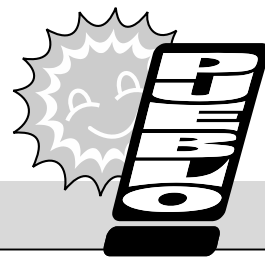

Rocky Mtn. Media Watch critiques news coverage of policy issues in Colorado

RMMW 2/17—Rocky Mountain Media Watch has announced it will monitor statewide news outlets and spotlight journalistic lapses (e.g., factual errors, omissions, lack of fairness) in coverage of policy issues through 2010. In addition to media criticism, the media watch organization will present local perspectives on journalistic issues—

as it did on its blog www.bigmedia.org earlier today.

The project will review statewide print media, local TV news and public affairs shows, and news and talk radio.

“We hope in our small way we can keep reporters honest...or at least give them something to think about,” said former Rocky Mountain News media critic Jason Salzman, who’s directing the effort. “We have a progressive perspective, which we’re not hiding, but we’ll do our best to present differing views accurately. We want to be fair, like my columns in the Rocky tried to be.”

The Media Watch work will be posted on Bigmedia.org, the Rocky Mountain Media Watch website <<http://www.bigmedia.org/>> and cross-posted on other blogs, and authored by Salzman.

Founded in 1994, Rocky Mountain Media Watch is a Colorado-based nonprofit organization aiming to hold journalists to their own professional standards, like those promulgated by the Society of Professional Journalists and others. RMMW gained national acclaim for its analyses of the local TV news industry in the late 1990s. Over the past five years, the organization has been mostly dormant. Funding for the project, which will run at least through 2010, is provided by a group of donors.

USDA says Recovery Act boosting rural Colo. projects

USDA 2/17—Approximately one year ago, Colorado was one of 20 states to receive funding from the \$84 million dollar Watershed Rehabilitation Allocation of the American’s Recovery and Reinvestment Act (ARRA). ARRA watershed projects were funded to improve water quality, increase water supply, decrease soil erosion, and improve fish and wildlife habitat in rural communities. There were five projects identified in Colorado totaling some \$3.6 million in assistance.

The Colorado Beaver Creek, the Highline Breaks, the Holbrook Lake Ditch, the Limestone-Graveyard Creeks, and the Trinidad Lake North

Continued from Page 1 watershed projects make up Colorado's five projects with \$2.5 million going to Beaver Creek, located within the northeastern portion of the state and the remaining \$1.1 million to the four located in

southeastern Colorado. "Within the past year, ARRA funds have afforded NRCS the opportunity to address some pressing natural resource con-

cern within these areas," said Allen Green, NRCS State Conservationist, in Lakewood.

Trinidad Lake North Watershed (TLNW) Project

One of the five Colorado watershed projects approved for funding included the Trinidad Lake North Watershed (TLNW) Project in the Trinidad area which is to receive approximately \$60,000.

The project area encompasses approximately 111,100 acres. The conservation practices installed will help improve water quality, improve irrigation system efficiencies, and reduce irrigation-induced erosion. "We are very pleased that the TLNW Project was one of the five watersheds in Colorado to receive funding," states John Knapp, USDA Natural Resources Conservation Service (NRCS) Area Conservationist, La Junta. The project area is in Las Animas County.

NRCS is a federal agency within the Department of Agriculture which manages and administers the technical and financial assistance for these watershed projects. The funds for these watershed projects go directly to the producers. Money will be spent locally for materials and contractors.

NRCS partners in the TLNW Project include the Spanish Peaks Purgatoire River Conservation District, Purgatoire River Conservancy

District, Las Animas County, City of Trinidad, and Colorado State Conservation Board.

Since the Recovery Act was signed into law a year ago, USDA has moved to get dollars out the door. Aside from funding for the Supplemental Nutrition Assistance Program, which is allocated on a mandatory basis each month, USDA

has announced the vast majority of its remaining \$7.9 billion to support more than 90,000 grants, loans, and other job-creating projects. In the first year implementing the Recovery Act, USDA has provided over \$100 billion in tax relief for American businesses and families, including tax cuts for 95 percent of working families.
