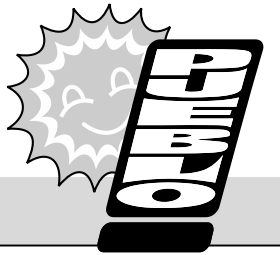

## State has over \$2 million in undelivered IRS refunds

IRS 11/18—The Internal Revenue Service is looking for 2,120 Colorado taxpayers who are due refund checks worth \$2,156,188, after those checks were returned as undeliverable. The refund checks, averaging \$1,017, can be claimed as soon as taxpayers update their addresses with the IRS.

Nationwide, 111,893 taxpayers had about \$ 164 million in refunds returned to the IRS. The average national undelivered refund is \$1,471.

Refund checks are mailed to a taxpayer's address on his/her tax return. A refund check is normally returned as undeliverable when a taxpayer moves without updating his or her address with either the U.S. Postal Service or the IRS.

"Each year the IRS distributes this list in the hopes of capturing the attention of those who may have missed their refund check," said Karen Connelly, IRS spokeswoman for Colorado. "By providing a cor-

rect mailing address now, generally people can expect their refund checks in time for the holidays."

There are several ways for taxpayers to update their addresses and claim their refunds. The "Where's My Refund?" Tool on IRS.gov enables taxpayers to check the status of their refunds. The tool will provide the status of the refund and, in some cases, provide instructions on how to resolve delivery problems.

Taxpayers can update their addresses with the IRS on the "Where's My Refund?" website feature. If accessing the Internet is not possible, taxpayers can call 1-800-829-1954 and receive instructions on how to update their mailing information.

The IRS encourages taxpayers to use Direct Deposit, which would put an end to undelivered refunds, as well as lost or stolen refund checks. Direct Deposit is available for filers of both paper and electronic returns.

## Pertussis cases up; vaccinations advised

ColHealth 11/18—Due to a notable increase in the number of pertussis (whooping cough) cases reported in Colorado since July, the state health department is recommending expanded use of vaccine for various age groups.

From July 1 through Nov. 13 of this year, 229 pertussis cases have been reported, compared to the 2007-2009 average of 77 cases per year during the same calendar period.

Compared to the same time period of 2007-2009, pertussis rates have increased the most in children 11-14 and 7-10 years of age, but smaller increases have been observed in other age groups as well. Notably, however, rates are lower in children less than 6 months old compared to the same calendar period during the three previous years.

Pertussis during early infancy frequently is severe and potentially fa-

tal. While Colorado has not yet seen an increase in pertussis in young infants, state health officials are very concerned the overall increase in disease could lead to additional cases in infants.

The Colorado Department of Public Health and Environment is recommending the following:

- DTaP (Diphtheria, Tetanus and Pertussis) vaccination of all infants at 2, 4 and 6 months
- DTaP vaccination booster for all children at age 12-15 months
- DTaP vaccination booster for all children at age 4-6 years
- Tdap (Tetanus, Diphtheria and Pertussis) vaccination booster for all adolescents at age 11-12 years
- Tdap vaccination booster for adolescents 13-18 years (who have not received a Tdap booster)
- Tdap vaccination booster for adults less than 65 years old

## Pertussis up; vaccinations advised

In addition, people who are caring for an infant or are a member of a household with an infant, should be vaccinated. This includes

- all adult infant care providers with Tdap vaccine including adults age 65 and older;
- underimmunized preadolescents (ages 7-10 years) with Tdap vaccine.

The department recommends that people contact their health care provider for the vaccinations.

Joni Reynolds, director the state's Immunization Program at the Department of Public Health and Environment, said, "Pertussis is a highly contagious disease, making unimmunized or incompletely immunized infants particularly vulnerable. By vaccinating family members and those who live or work around these young children, we better protect infants and young children."

Reynolds explained that pertussis affects the airways and may be milder in adolescents and adults, especially those who have been vaccinated. However, pertussis can cause severe illness especially in young infants, and in rare cases can be fatal. Babies cannot begin the first of the three recommended pertussis infant vaccinations until they are at least 6 weeks old.

Since Sept. 1, the largest numbers of pertussis cases in Colorado have been reported from Jefferson and Arapahoe counties, followed by Pueblo, Boulder, Denver, Adams, Douglas, Weld and El Paso counties, all of which show a substantial increase over the past two years for the same period. A number of smaller counties that usually report no cases for this time period have reported small numbers of cases since September 1.

**Health Service Corps grant funds recruiting for underserved areas**

ColoHealth 11/4 — To tackle the growing shortage of health care providers in rural and urban communities across the state, the Colorado Health Foundation will grant \$6.48 million to the Colorado Health Service Corps (CHSC) to repay student loans for doctors and other primary care health professionals in return for providing care in the state's most underserved areas.

"More than a million Coloradans live in communities where physicians and other primary care resources are scant or nonexistent," said Foundation President and CEO, Anne Warhover. Eighty-two percent of Colorado counties have a primary care professional shortage, 53 percent have a mental health professional shortage and 40 percent have an oral health professional shortage.

Access to primary health care services also helps to boost communities economically. For example, studies show that each primary care physician can generate nearly \$900,000 in income through wages, salaries and benefits in the community and create 22.9 jobs.\*

The award to the CHSC, administered by the Primary Care Office of the Colorado Department of Health & Environment

(CDPHE), is expected to fund more than 48 physicians, nurses, physician assistants, dentists, dental hygienists and behavioral health providers during the next three years (2011 -- 2013). These professionals each make a three-year commitment to practice in a Federally Qualified Health Center (FQHC), rural health clinic or other safety net facility in a rural or underserved urban community.

The CHSC supports clinics in underserved areas that provide care to uninsured and underinsured patients. Typically, these clinics find it difficult to recruit and retain new health care professionals because of perceived challenges that come with providing rural and underserved care. "Loan repayment is an excellent way to increase recruitment and retention of health care professionals in practices that meet the needs of Colorado's medically underserved," said Stephen Holloway, director of the Primary Care Office for the CDPHE. "Though contracts typically last three years, we actively seek candidates who are likely to remain in a community long after their obligation is complete."

The Colorado Health Foundation began funding loan repayment awards to physicians through the Physician Loan

Repayment Program in 2006. In 2009, the Foundation began funding loan repayment through CHSC in the amount of \$663,000, significantly expanding the Foundation's awards to include other health care professionals. This round of funding increases the Foundation's financial commitment, strengthening support for a broad range of health professionals in the corps. Through these two efforts, the Foundation has awarded 67 loan repayment awards to 49 physicians and 18 other health care professionals.
