"Colorado already has the most stringent oversight of oil and gas production of any state in the nation," said Tony Gagliardi, Colorado state director for the National Federation of Independent Business, "so when someone wants to add an especially needless layer of regulatory authority, you can't help but look for ulterior motives."

NFIB was responding to reports that Gov. John Hickenlooper is considering calling a special session of the Colorado Legislature to pass a proposal giving local governments more control in oil and gas regulations. The governor is getting some support for the effort from several other business groups, because it might head off some multi-million-dollar November ballot initiatives.

"We already have a state oil and gas commission overseeing the nation's most stringent regulations," said Gagliardi, "so whose political agenda is being served by allowing 64 counties to add their layer of rules?..."

I-25 project underway in **Huerfano County**

CDOT 6/3) — The Colorado De- | delineators and striping. partment of Transportation (CDOT) is beginning work to resurface and upgrade several bridges on Interstate 25 through northern Huerfano County (mile 47 - 59).

In addition to rotomilling and asphalt paving nine miles of I-25 from Walsenburg north to the Huerfano River, the project includes installing new expansion joints and repairing the bridge approaches on 10 structures. Other improvements include new guardrails, rumble strips, traffic

Drivers should anticipate single lane closures on northbound and/or southbound I-25 from 6 a.m. to 7 p.m., Monday through Friday. The speed limit is reduced to 45 mph through the project area during work hours. Traffic delays are possible so drivers should plan on extra travel time.

Width restrictions will be in place for vehicles wider than 12 feet through various segments of the work zone through mid-

Continued from Page 1 September. These restrictions will remain in effect 24/7.

"This project will give the traveling public a smoother road surface that'll last at least 10 years," said CDOT Project Manager Steve Spera. "Along with the bridge work, which is expected to extend the lifespan of all of the structures for several years, safety should be enhanced as well. Placing rumble strips alerts drivers when they're drifting out of the travel lanes and the new striping improves highway visibility, especially at night."

APC Southern Construction Co. of Golden, CO is the contractor for the \$9.5 million project. It is scheduled for completion in October 2014.

State Parks & Wildlife says don't handle young wildlife

mals give birth to their young and Colorado Parks and Wildlife asks that you not approach, touch or handle young animals.

"We know that people are trying to be helpful, but the young animals are best cared for by their own parents," said Renzo DelPiccolo, area wildlife manager in Montrose for Colorado Parks and Wildlife. "The best thing people can do is to leave young wildlife alone."

During spring and early summer, people often see young animals that appear to be alone in the forest, in backyards, on or near trails or along the sides of roads.

"The animals have not been abandoned. Young animals are often left alone to allow the mother to feed, to help them avoid predators and to learn how to live in the wild," DelPiccolo explained.

Deer provide a good example of how wildlife adapt behaviors to help them survive. Young fawns have no scent and are born with speckled coats that provide a natural camouflage. These two factors help them avoid being found by predators. | stincts can find animals and at-

moves away. Many other animals use similar survival techniques.

Elk and moose calves are also left alone by their mothers. If you see one, move away quickly. Do not move closer or attempt to get the animal to move.

A disturbing situation occurred in Vail earlier this week when a moose calf was apparently chased by children into a hotel lobby where it collapsed. The animal was picked up by a wildlife officer and is now at a CPW facility in Fort Collins.

Young birds often fall out of their nests or are pushed out of nests by parents to encourage them to fly.

"If a young bird is on the ground it will quickly learn to fly. So let nature take its course," DelPiccolo said.

If you see a bird on a hiking trail and you think it might be stepped on accidentally or easily found by a dog, you can pick it up and move it a short distance to cover.

People also need to keep their pets under control. In the woods, dogs acting on their natural in-

"Many studies show that cats are damaging the songbird population. Please, don't let your cat roam free," DelPiccolo said.

Cat owners who are concerned about songbirds will place a small bell on the cat's collar and the sound will alert small animals.

Food should never be given to wildlife. There is plenty of natural food available for wild animals. Providing food causes animals to bunch up in small areas and that makes them vulnerable to diseases and predators. If they're provided food they also become habituated to humans and will stay in residential areas instead of natural lands.

People also need to understand that not all newborn animals will survive. "In the case of all wildlife, we have to understand that mortality is part of the natural cycle," DelPiccolo

CU Denver study finds serious challenges to 'New Urbanist' communities

DU 6/10) – As New Urbanist communities expand nation-wide, a study from the University of Colorado-Denver shows tough challenges of balancing complex traffic engineering systems with the ideals of walkable, sustainable neighborhoods.

As a leading public research university located in the urban core, CU Denver researchers have ample opportunity to connect their work to the city of Denver and surrounding communities. This study focused on Denver's Stapleton neighborhood, one of the largest New Urbanist developments in the nation, specifically examining its street network, street design and intersections.

"I was investigating the inconsistencies of what was built with respect to the latest research and state-of-the-art New Urbanist thinking," said study author Wesley Marshall, PhD, PE, assistant professor of civil engineering at CU Denver College of Engineering and Applied Science. "The deviations from the standard model of New Urbanism were then considered in terms of how people are actually using the system, by way of vehicle speed studies and travel diaries."

Broad ideas vs. reality

Marshall said Stapleton, like similar developments, began with a set of guiding principles but made compromises due to competing conventional traffic engineering standards.

One of those principles relies on narrow streets to restrict travel speeds for increased safety. Yet while on-street parking is a New Urbanist tool to slow traffic and buffer pedestrians, it isn't as effective in Stapleton since most homes come with mandated off-street parking, the study said.

"Underutilized on-street parking has been shown by various researchers to be associated with higher vehicle speeds as well as higher crash rates," Marshall said. "Even where on-street parking is well used, many of Stapleton's residential streets are still too wide; as a result, unsafe vehicle speeds are the norm"

Stapleton's street network also includes two overly-wide major thoroughfares — Martin Luther King and Central Park Blvds, he said. Marshall found that the 35 mph speed limit on Martin Luther King Blvd. was exceeded 18 percent of the time while the 30 mph on Central Park was exceeded 22 percent of the time.

"If we have streets in a New Urbanist neighborhood where it's possible for drivers to go 50, 60 or 70 mph, then we've done something wrong," Marshall said. "The problem is not a lack of police enforcement; it's a lack of self-enforcing streets."

The study also found that Stapleton and Lowry, a similar development nearby, lagged behind older Denver neighborhoods in terms of walking, biking and public transit use. That may change in 2016, Marshall said, when a commuter line from the central business district to Stapleton is completed, but that is not quite enough.

Marshall said Stapleton, with over 14,000 residents, does many things right. There is a lot of connectivity for pedestrians and bikes, there are great sidewalks, the schools and restaurants are close, and the area looks inviting. But he said the downsides are also real.

"Stapleton serves as a reminder that the transportation design ideals of New Urbanism can too easily be compromised by a conventional traffic engineering mindset," Marshall said. "The results are higher-than-desired vehicle speeds on every kind of street; higher driving mode shares, and less walking, biking and transit use than peer neighborhoods in the region."

The solution requires a return to the original ideals of Stapleton with narrow, connected streets, less off-street parking, and less dependency on automobiles, he said.

"If we don't better deal with this disconnect between New Urbanist ideals and conventional engineering solutions, then Stapleton will end up just like any other auto-oriented development," Marshall said.

The study was published March 31, 2014 in the Journal of Urbanism: International Research on Placemaking and Urban Sustainability.

The rules were adopted by the Ag Commission and became effective June 11, 2014. Those interested in farming industrial hemp, who have not already registered, can begin the registration process.

The emergency rule changes are the result of amendments to the Colorado Industrial Hemp Program Act (SB14-184) passed during the recent legislative session. The Act eliminates the May 1st registration deadline and implements a new registration deadline of 30 days prior to planting. The rule changes also require registrants to file a report with the Commissioner 30 days prior to harvest rather than the seven days previously specified. A proposed harvest date must also be provided.

To date, approximately 1543

total acres have been approved for planting industrial hemp. Of that, 1309 acres can be grown for commercial purposes and 234 acres for research and development. A letter has been sent to all registrants informing them of the rule changes.

AIM Index says Colorado workforce is strong and improving

Denver 6/10) – AIM's Colorado May Work Force Index (WFI) rose to 69.1 from 65.8 in April. The WFI is a statistically based measurement tool produced by AIM, a nonprofit organization in Denver. The Index is a ratio of unique online job postings and the number of unemployed in Colorado (not seasonally adjusted).

The Index ranges between 0 and 100. A WFI below 50.0 indicates short-term economic contraction while an Index above 50.0 indicates economic expansion. At 69.1 for May and 65.8 for April, Colorado's WFIs are in a range indicating healthy and improving on-line job growth.

In May, online job postings listed the largest number of open in 1) Sales, followed by 2) Management, and 3) Customer Services positions. As a share of employment, the largest number of job openings in descending order were: 1) Finance, 2) Engineering, and 3) Customer Services.

In terms of indices among the states, North Dakota ranked number one with the highest WorkForce Index. North Dakota was followed by Kansas at number two, South Dakota at three, Wyoming at four, and Nebraska at five. The state with the lowest index was Maine, followed by California and New York. Colorado ranked as the 18th best in the nation for May 2014 which was an improvement over the state's April ranking of 19.

About the AIM WorkForce Index

AIM and the Creighton University College of Business produce the AIM WorkForce Index each month to track the relationship between the WFI and the changes in the U.S. Gross Domestic Product. This comparative analysis measures the relative strength of the Colorado labor market. It can also be compared to Creighton University's monthly survey of bank CEOs in 10 states including Colorado. Creighton's survey has also been pointing to an expansion in the Colorado Rural Mainstreet

Dear EarthTalk: How is it that our more effectively managing ocean resources could help us better feed the world?

— Missy Jenkins, Boone, IA HUNGER is a growing problem around the world, in both developing and developed countries. As our population continues to rise, the amount of arable land per capita is declining and climate change is either drying out or flooding many formerly productive agricultural belts, making it more and more difficult to keep up with the growing demand for food. The United Nations Food and Agriculture Organization (FAO) reports that we must produce 70 percent more food globally if we are to feed the world's increasing numbers of hungry people in the coming decades.

While more efficient agricultural practices can help, conservationists are increasingly looking to the ocean as a potential way out of our hunger woes. According to Oceana, a leading non-profit dedicated to protecting the world's oceans and marine biodiversity, wild seafood "requires no fresh water, produces little carbon dioxide, doesn't use up any arable land and provides healthy, lean protein at a cost per pound lower than beef, chicken, lamb and pork, making it accessible to the world's poor."

But like other natural resources, fish stocks have also been in decline in recent years as a result of decades of overfishing. "The global fish catch peaked in the late 1980s and has been declining ever since," reports Oceana. Indeed, data show the amount of fish caught around the world has fallen by some 18 percent over the last three decades. "If current trends continue, we'll only have enough wild seafood to feed half the world's population in 2050," says the group.

But that downward trend could be reversed by overhauling fisheries management, protecting fish spawning and breeding habitat and reducing by-catch (the incidental catch of species not targeted by fishermen). In areas where fisheries managers have been able to set catch limits based on fish biology instead of industry interests, seafood populations have started to bounce back. Likewise, fish stocks have recovered significantly in the water column in and around Marine Protected Areas (MPAs) and other critical "no-fish" zones.

"These are steps that have been proven to restore stocks of fish wherever they have been implemented," adds Oceana. "While it's counterintuitive, by imposing limits to what we catch today we will actually be able to increase the amount of fish that we catch tomorrow." The group cites research showing that "sensible management" could increase fish yields up to
