Women's earnings not gaining in Colorado

women who were full-time wage and salary workers had median usual weekly earnings of \$762 or 77.9 percent of the \$978 median usual weekly earnings for their male counterparts, the U.S. Bureau of Labor Statistics reported Friday.

Regional Commissioner Stan W. Suchman noted that the women's to men's earnings ratio in Colorado decreased 0.4 percentage point from 2012. Nationwide, women earned \$706 per week, or 82.1 percent of the \$860 median for men.

In Colorado, the ratio of women's to men's earnings recorded a low of 74.6 percent in 1997. The ratio rose above 80 percent in 2002 and remained there through 2007, but has dipped below that mark in 5 of the most recent 6 years.

Among the 50 states, median weekly earnings of women in full-time wage and salary positions in 2013 ranged from \$591 in Louisiana and Oklahoma to \$900 in Massachusetts. States with the highest wages for women were located along the Eastern Seaboard. In addition to Massachusetts, women's earnings in Connecticut, Maryland, and Virginia were above \$800 per week. In the District of Columbia, women earned a median weekly wage of \$1,100.

Median weekly earnings for men were lowest in Arkansas at \$705 and highest in Massachusetts at \$1,109. Three other states (Connecticut, Alaska, and Maryland) had weekly wages above \$1,000 for full-time male

> Vermont had the highest female-to-male earnings ratio among the states, 91.3 percent, and Wyoming had the lowest, 68.6 percent. The District of Columbia had a ratio of 90.8 percent. The differences among the states reflect, in part, variation in the occupations and industries found in each state and in the age composition of each state's labor force. In addition, comparisons by gender are on a broad level and do not control for factors such as educational attainment which can be significant in explaining earnings differences.

Terms used...

Some definitions of terms used with the earnings data in this release are described briefly

Usual weekly earnings. The data represent earnings before taxes and other deductions and include any overtime pay, commissions, or tips usually received (at the main job in the case of multiple jobholders). Respondents are asked to identify the easiest way for them to report earnings (hourly, weekly, biweekly, twice monthly, monthly, annually, or other) and how much they usually earn in the reported time period. Earnings reported on a basis other than weekly are converted to a weekly equivalent. The term "usual" is determined by each respondent's understanding of the term.



Rick Basagoitia, area wildlife manager in Monte Vista, said that big game animals suffer horribly when they're attacked

"So often we see injured and mangled deer that survived the initial attack. They are barely clinging to life and have no chance of making it through the winter," Basagoitia said. "Then we have to do something we hate to do, we put them down."

Many pet owners believe that their dogs would never chase wildlife. The fact is that most dogs, given the chance, follow their ancient predator instincts and will chase wildlife.

"Once a dog or group of dogs starts this behavior they rarely stop because they quickly learn to enjoy the chase," Basagoitia said.

But this behavior can also lead to a dog's demise. If a wildlife officer or other law enforcement officer sees dogs chasing deer or elk, Colorado law allows the dog to be shot.

We don't like to take drastic action against dogs. Dealing with the dog owners is the best way to prevent these types of incidents," Basagoitia said.

There are many reasons dogs should be kept on a leash when walking in areas where wildlife are present. One dog owner in the Gunnison area found out the hard way early in January while walking his pet in the popular Hartman Rocks recreation area.

The dog was running free and disappeared over a rise. A couple of minutes later the dog reappeared — running from a mountain lion. The cougar caught the dog and injured it slightly before being chased off by the owner. The dog survived and the pet owner learned a lesson.

"I believe that the lion was protecting a food cache nearby, probably a deer that it had killed," said J Wenum, area wildlife manager in Gunnison. "The lion was being a lion. There's a reason why dogs should be on a leash."

Even in seemingly controlled environments like state parks, dogs are required to be on a leash. At Ridgway State Park dogs often chase wildlife, other dogs and even people.

'When we contact owners whose dogs have attacked wildlife or bitten someone, they always insist that their dog has never behaved like that," said Kirstin Copeland, Ridgway park manager. "But we know that dogs act differently when they're taken out of their normal environment."

CPW officials know that people in Colorado love their dogs. But they also have a responsibility to assure that their animals don't become a hazard to wildlife, people and other

"It's not difficult to keep a dog under control and to train it properly," said Patt Dorsey, southwest regional manager for Colorado Parks and Wildlife. "Keep your dogs secure when you're at work during the day. Let's give wildlife a chance"

It'll Never Be Time for Term Limits on Congress

It didn't get much attention at the time, but the elections last November did more than give Republicans a majority in the U.S. Senate. Voters also added to the ranks of people on both sides of Capitol Hill who believe members of Congress should serve a limited number

I know a lot of people to whom this is good news. I know them, because I hear from them every time I speak at a public event that allows for a give-andtake with the audience. Americans are frustrated with the federal government as a whole and with Congress in particular, and are searching for a simple solution. The notion that the bums could be thrown out automatically has great appeal.

Yet as popular as the idea might be among the public at large, it has no traction on Capitol Hill. The fundamental problem is that any measures imposing limits will need the support of leaders who, almost by definition, have served a long time. They're not going to put themselves out of a job they like. Small surprise that bills calling for term limits don't even make it out of committee.

Now, I should say right up front that you're not going to hear a strong argument in favor of term limits from a guy who served 34 years in Congress. I'm biased. But I want to spell out the reasons for my bias, not because I think term limits are a burning issue in Washington they're not — but because I wish they were less of an issue for ordinary voters.

Congress has a lot of problems right now, and the American people have a role to play in fixing them, but term limits are a distraction from the truly hard work that needs to be done.

When you boil down all the debating points for and against term limits, there are two that bear the crux of the argument. The first has to do with the nature of our democracy. Supporters of the idea believe that bringing in fresh thinking and new leaders on a regular basis will make Congress more representative. However, stripping voters of the right to re-elect a representative whom they've supported in the past does not make for a more democratic system — rather, less.

Representative government rests on the notion that voters get to choose their legislators. Telling them that this is true for all candidates but one — the incumbent — does not strengthen voters' rights; it reduces their choices.

It also weakens Congress. And that's the other key issue.

The most important point to remember in all this is that if you take power away from a senior legislator, that power does not evaporate. Instead, it flows to the bureaucracy and the President. Serving productively in Congress is a tough, exacting task. It demands a deep knowledge of the issues that confront the country; a keen eye backed by years of experience — for the ways in which executive agencies can go off track and then seek to hide that fact; insight into the ways in which both allies and opponents on any given issue might be motivated to shift their positions; and the hard-earned wisdom to forge common ground among competing interests and ideologies.

These traits come neither quickly nor easily. Kicking members of Congress out of their seats just as they're gaining the ability to legislate effectively and oversee the government responsibly demotes Congress to the status of a minor agency. A politician elected to a limited term immediately begins looking for another job, which reduces his or her effectiveness and attention to the job at hand.

Moreover, in government, information is power. Legislators constantly come up against executive branch expertise backed by thousands of employees and big budgets. Legislators without expertise are at a strong disadvantage.

Term limits are not the solution to the real dysfunction that besets Washington. They reduce the choices of voters and accelerate the accumulation of power in the executive branch. They move representative democracy in the wrong direction.

Camping reservations limited by construction at Lake Pueblo State Park

ColParksWild 1/12)-Lake Pueblo State Park is beginning construction on new comfort station facilities in Northern Plains and Arkansas Point Campgrounds. During this time visitors may experience construction traffic and periodic campground closures.

Lake Pueblo State Park is installing 12 new comfort stations, containing bathroom and shower facilities, that will be built of precast concrete and be able to withstand the rigors of outdoor recreation usage. The facilities will also be easier to maintain than the existing comfort stations, which are more than 20 years old and do not meet current ADA requirements.

"We hope that you will 'Pardon our dust,' as we look to the future and begin updating our facilities to better serve our visitors," said Park Manager, Monique Mullis.

The construction is slated to continue through the spring and be completed by early summer. During this time campsites in the Northern Plains, Arkansas Point and Eagle View Campgrounds will not be able to be reserved through the Colorado Parks and Wildlife reservation system, Reserve America, until further notice.

However, sites in the "A Loop" in Arkansas Point Campground and all of Eagle View Group Campground sites are still available for "first-come, first-served" camping during this time.

Juniper Breaks Campground is not part of the construction contract and will experience no change in reservation status.

Visitors should be aware that construction traffic in the park will be increasing through the spring and early summer and periodic closures and/or power outages in Arkansas Point Campground, Loop A may take place.
